# Victoria Quay Christmas Carnival Prize Draw 7 December 2019

## TERMS AND CONDITIONS

- Fremantle Ports invites you to enter into the Victoria Quay Christmas Carnival Prize Draw ("Prize Draw") for a chance to win a family trip to Rottnest ("Prize"). The Prize Draw is promoted by Fremantle Ports.
- 2. The Prize comprises of the following:
  - Two adult and 2 child tickets (on a return basis) to Rottnest Island via Sealink & Rottnest Express departing B Berth Victoria Quay Fremantle or from Northport Rous Head, Fremantle;
  - ii. The Prize Winner may also accept as the Prize, 1 or 2 adult tickets and/or 1 or 2 child tickets:
  - iii. Loading fees are included in the Prize;
  - iv. The dates that the Prize can be used are from and including 9
    December 2019 up to and including 31 October 2020;
  - v. The Prize Winner (as defined below in clause 18) is entitled to select the dates and times for the return voyage to Rottnest Island provided those dates and times fall within 9 December 2019 and 31 October 2020;
  - vi. In the event that the dates and times selected by the Prize Winner are not suitable to the ferry operator, then Fremantle Ports takes no responsibility for that unavailability of the ferry operator and it is the responsibility of the Prize Winner to change the dates and times of the voyage to suit the Prize Winner and the ferry operator;
  - vii. All tickets that are redeemed by the Prize Winner must be used contemporaneously on the one return voyage.
- 3. The terms and conditions of entry and participation in the Prize Draw ("Conditions of Entry") are set out below.
- 4. By submitting your entry into the Prize Draw in accordance with these Conditions of Entry, you acknowledge that:
  - (a) you have read, understood, accepted and agreed to be bound by these Conditions of Entry;

# Entry

- 5. Entry is open to Australian residents only. You may be required to provide Fremantle Ports with proof of identity and residency, to Fremantle Ports' satisfaction. Identification considered suitable for verification of residency is at the discretion of Fremantle Ports.
- 6. Entry is not open to directors, officers, management and employees and other staff (and the immediate families of directors, officers, management, employees and other staff) of Fremantle Ports or of the agencies or companies associated with this Prize Draw.
- 7. The Prize Draw will be open for entry during 3.00pm to 7.45pm (WST) on Saturday 7 December 2019.

Please ensure that the details on the completed Entry Form are clearly legible (readable) as Fremantle Ports takes no responsibility and accepts no liability for illegible completed Entry Forms that are deposited into the box or if the details have not been completed correctly (or if there are errors or omissions in the completed Entry Form).
- If you submit an incomplete or illegible Entry Form, your Entry Form may be rejected by Fremantle Ports and you may be disqualified from the Prize Draw at the discretion of Fremantle Ports.

- 11. The Entry Form must be deposited into the properly identified Entry Form box by no later than 7.45pm (WST) Saturday, 7 December 2019. The closing date and time of the Prize draw is 7.45pm (WST) Saturday 7 December 2019. Entry Forms that are deposited after that time and date, will be rejected by Fremantle Ports and not be included in the Prize Draw.

#### **Prize Draw**

- 18. Fremantle Ports will conduct the Prize Draw at 8.00pm (WST) Saturday 7
  December 2019 to determine the winner of the Prize ("**Prize Winner**").
- 19. The method of the Prize Draw is to be at Fremantle Port's absolute discretion. Participants have no claim or right of appeal against Fremantle Ports in respect to the determination of the Prize Winner.
- 20. The general process to be followed by Fremantle Ports to determine the Prize Winner, is that Fremantle Ports will conduct the Prize Draw by randomly

selecting an Entry Form directly from the Entry Form box (and if there is more than 1 Entry Form box then after all of the Entry Forms have been deposited by Fremantle Ports into one container to hold all of the Entry Forms to enable one Entry Form to be randomly withdrawn from that container containing all of the Entry Forms).

- 21. Participants in the Prize Draw need not be present at the Prize Draw to win and be the Prize Winner.
- 22. The Prize Winner will be notified by email on Monday 9 December 2019. If the Prize Winner does not respond to Fremantle Ports within 7 days of being notified by Fremantle Ports confirming receipt that the person is the Prize Winner, the Prize afforded to the Prize Winner will be forfeited and lost and Fremantle Ports will be entitled to undertake a second Prize Draw in accordance with the process described above.
